In pursuance of tender No. CREST/EOI/2020-21/8 published on dated 24.07.2020 for invitation of expression of interest for empanelment of Manufacturers/ System Integrators for Rooftop Grid connected SPV Power Plants in Chandigarh for F.Y. 2020-21, 12 Nos. of bidders are hereby empanelled by CREST in different categories for installation of SPV Power Plants in U.T., Chandigarh for capacity of 1 kWp to 10kWp w.e.f. the date of issue of this order. **Residents of Chandigarh interested to install SPV Power Plants and want to avail upfront subsidy from Empanelled agencies have to install SPV Power Plants only from one of empanelled agencies of CREST.** But, the subsidy for the same shall be released to the Empanelled agency after commissioning of the project and receipt from MNRE (GOI) on the basis of L-1 rates of category 1kWp to 10kWp arrived through this e-tendering or on the basis of MNRE (GOI) Benchmark Cost, whichever is lower as per MNRE (GOI) Ph-II guidelines issued vide office memorandum no. 318/331-2017-Grid Connected Rooftop dated: 20.08.2019 or as decided by Ministry of New & Renewable Energy, Govt. of India, time to time. The category wise L-1 rates arrived are as following:

The above said category wise L-1 rates for 1kWp to 10kWp is applicable w.e.f. the date of issue of this order. The category wise details of empanelled agencies of CREST for installation of 1kWp to 10kWp SPV Power Plants in Chandigarh are enclosed in **Annexure-I** for further facilitation to general public of Chandigarh for installation of SPV Power Plants.

After installation and commissioning of SPV Power Plant, the Empanelled agencies are advised to inform CREST for its verification. **The Verification Report/ Joint Commissioning Report shall be forwarded to MNRE (GOI) for release of subsidy.** The subsidy as and when received from MNRE (GOI) shall be released to Empanelled agencies by CREST. The subsidy will be released to the Empanelled agencies only for the category in which they are empanelled.

Any Empanelled agency found violating the MNRE (GOI) guidelines Ph- II issued by MNRE (GOI) vide office memorandum no. 318/331-2017-Grid Connected Rooftop dated: 20.08.2019 and clarification issued vide letter no. 318/331/2017\_GCRT dated 30.01.2020 and terms and conditions of DNIT for expression of Interest for empanelment shall be liable for delisting from the empanelment of CREST.
